By submission of your application, you will be contacted in 1-2 business days to set up payment options for a membership account. Willow Springs Country Club Bylaws and Member Contract will be sent to you for your signature and return.

MEMBERSHIP TERMS AND CONDITIONS:

PAYMENT ON MEMBERSHIP ACCOUNT: Monthly dues plus any additional charges that are incurred from a membership account are set up through draft from a current bank account or credit card between the 1st and 5th of each month. Membership contract extends for 12 months beginning on date of first bank draft. Note: If your application is submitted during membership drives or other specials, any waived fees and discounts will be applied upon the initial set up of member account and will be detailed in the member contract.

CANCELLATION PROCEDURES: After 12 month contract is completed, WSCC will continue to draft members bank account or credit card between the 1st and 5th of each month for membership dues plus any additional monthly charges unless a signed written notice of cancellation is submitted. Membership dues are not prorated at cancellation. Therefore, cancellations on member accounts will be completed on first of the following month upon receipt of written cancellation notice. Member must submit cancellation notice before the 1st of the month to avoid additional charges on their account.

CHANGES TO ACCOUNT INFORMATION: It is member responsibility to immediately notify WSCC should any change take place to the draft, credit card information, and/or contact information associated with the account.

MEMBER RESPONSIBILITY: Member is not released from responsibility to complete the duration of the 12 Month contract except a leave for active military service or death. Should member withdraw for any other reason before the contract expires, then member is obligated to pay half of the initiation fee according to WSCC by-laws; Under 40 Single and Non-Res.(\$150), Under 40 Family and Full Single Golf (\$200), Full Family Golf (\$400). Each membership will be required to meet a \$10 monthly minimum in food purchases in the snack bar or proshop.

WSCC BY-LAWS: A full and complete copy of Willow Springs by-laws are submitted to member applicant upon the submission and review of application. By-laws must be signed by member applicant in order to set up account for membership.
